- Large Corporate (international/national firms)
- Regional Commercial (UK regionals with Manchester presence)
- Boutique / Independents (smaller Legal 500 niche firms)

Salary data is drawn from live mandates, candidate offers and firm announcements during 2025. Figures represent base salary only (excluding bonuses and benefits).

This report reflects what we see in the Manchester market today.

#### Firm Examples (Tier Definitions)

Large Corporate (International / National)

International and national firms with Manchester offices, handling premium work for global and FTSE-listed clients.

Examples: Addleshaw Goddard, CMS, Eversheds Sutherland, Pinsent Masons, Shoosmiths, Squire Patton Boggs

Regional Commercial (UK Regionals with Manchester Presence)

UK regional firms with a strong Manchester base, combining quality work with greater accessibility and balance than the largest corporates.

Examples: Brabners, Mills & Reeve, TLT, Freeths, Ward Hadaway, Knights

Boutique / Independents (smaller Legal 500)

Smaller Legal 500-ranked practices, often specialist or Manchester-only, offering high-quality work in a more close-knit environment.

Examples: Beyond Corporate, Pannone Corporate, Kuits

### Market

Included: Legal 500 ranked regional, national and international firms with a Manchester presence.

Excluded: High street and general practice firms, along with non-commercial disciplines.

Outliers: DLA Piper's £82,000 NQ package is excluded as it represents a London-style outlier and is not reflective of the broader Manchester market.

## **Bonuses & Extras**

The figures above reflect base pay only. In practice, most firms also offer extras including:

- Annual or performance-related bonuses
- Enhanced pension contributions
- Private healthcare and wellbeing benefits
- Flexible or hybrid working arrangements

## Thornton Legal Insights

- NQ Benchmarks: At large corporates, top NQ salaries sit between £65,000-£70,000. Regional commercial firms typically pay £55,000-£60,000, while boutique independents are generally in the £48,000-£55,000 range.
- Market Position: Manchester remains the strongest legal centre in the North, with the broadest range of international and national firm opportunities. However, there is a clear spread between the large corporates at the top of the market and the boutique independents.
- Leeds Comparison: Salary levels are broadly aligned with Leeds, particularly at large corporates where pay bands are almost identical.
- Liverpool Comparison: Manchester consistently commands a premium of around £5,000-£10,000 at NQ level.

## **Challenges for Lawyers**

- Intense competition for roles at large corporates, where firms can be highly selective.
- Bottlenecks at Senior Associate and Legal Director levels, limiting upward mobility.
- Need to balance salary uplift with hybrid working and lifestyle considerations.
- Wider pay gap between corporates and boutiques makes cross-tier moves more complex.

## **Challenges for Law Firms**

- Talent retention is increasingly difficult as associates are tempted by London or international opportunities.
- Salary inflation at the top end makes it harder for regional firms to remain competitive.
- Growing expectations around hybrid working and wellbeing mean firms must offer more than just salary.
- Competition between Manchester firms for strong NQs and mid-level lawyers is pushing up recruitment costs and time-to-hire.
